

HORIZONS ANNOUNCES AUGUST 2016 DISTRIBUTIONS FOR CERTAIN ACTIVE ETFS

TORONTO – **August 22, 2016** – Horizons ETFs Management (Canada) Inc. and its affiliate AlphaPro Management Inc. (collectively "**Horizons ETFs**") are pleased to announce the distribution amounts per unit (the "**Distributions**") for certain of the Horizons ETFs family of exchange traded funds (the "**ETFs**"), for the period ending August 31, 2016, as indicated in the table below.

The ex-dividend date for the Distributions is anticipated to be August 29, 2016, for all unitholders of record on August 31, 2016. The Distributions will be paid in cash, or if the unitholder has enrolled in the respective ETF's dividend reinvestment plan (DRIP), reinvested in additional units of the applicable ETF, on or about September 13, 2016.

The approximate Canadian dollar equivalent distribution rate for HUF is \$0.01708 per unit. For unitholders who hold Canadian dollar traded HUF, distribution payments will typically be converted to Canadian dollars by the unitholder's account holder.

Distributions for the ETFs will vary from period to period.
