

HORIZONS ANNOUNCES SEPTEMBER 2016 DISTRIBUTIONS FOR CERTAIN ETFS

TORONTO – **September 21, 2016** – Horizons ETFs Management (Canada) Inc. and its affiliate AlphaPro Management Inc. (collectively "**Horizons ETFs**") are pleased to announce the distribution amounts per unit (the "**Distributions**") for certain of the Horizons ETFs family of exchange traded funds (the "**ETFs**"), for the period ending September 30, 2016, as indicated in the table below.

The ex-dividend date for the Distributions is anticipated to be September 28, 2016, for all unitholders of record on September 30, 2016. The Distributions will be paid in cash, or if the unitholder has enrolled in the respective ETF's dividend reinvestment plan (DRIP), reinvested in additional units of the applicable ETF, on or about October 13, 2016.

The approximate Canadian dollar equivalent distribution rate for HUF is \$0.01754 per unit. For unitholders who hold the Canadian dollar traded HUF, distribution payments will typically be converted to Canadian dollars by the unitholder's account holder.
