

HORIZONS ANNOUNCES NOVEMBER 2016 DISTRIBUTIONS FOR CERTAIN ACTIVE ETFs

TORONTO – November 21, 2016 – Horizons ETFs Management (Canada) Inc. and its affiliate AlphaPro Management Inc. (collectively "Horizons ETFs") are pleased to announce the distribution amounts per unit (the "Distributions") for certain of the Horizons ETFs family of actively managed exchange traded funds (the "ETFs"), for the period ending November 30, 2016, as indicated in the table below.

The ex-dividend date for the Distributions is anticipated to be November 28, 2016, for all unitholders of record on November 30, 2016. The Distributions will be paid in cash, or if the unitholder has enrolled in the respective ETF's dividend reinvestment plan (DRIP), reinvested in additional units of the applicable ETF, on or about December 12, 2016.
