

## HORIZONS ANNOUNCES AUGUST 2017 DISTRIBUTIONS FOR ITS COVERED CALL ETFS

**TORONTO** – **August 23, 2017** – Horizons ETFs Management (Canada) Inc. and its affiliate AlphaPro Management Inc. (collectively "**Horizons ETFs**") are pleased to announce the distribution amounts per unit (the "**Distributions**") for the Horizons ETFs suite of covered call exchange traded funds (the "**ETFs**"), for the period ending August 31, 2017, as indicated in the table below.

The ex-dividend date for the Distributions is anticipated to be August 29, 2017, for all unitholders of record on August 31, 2017. The Distributions for units of each ETF will be paid in cash, or if the unitholder has enrolled in the respective ETF's dividend reinvestment plan (DRIP), reinvested in additional units of the applicable ETF, on or about September 13, 2017.

Monthly distributions will be paid in cash, unless the investor has chosen to participate in the ETF's reinvestment plan.
