

## HORIZONS ANNOUNCES FEBRUARY 2018 DISTRIBUTIONS FOR ITS COVERED CALL ETFS

**TORONTO** – **February 21, 2018** – Horizons ETFs Management (Canada) Inc. ("**Horizons ETFs**") is pleased to announce the distribution amounts per unit (the "**Distributions**") for the Horizons ETFs suite of covered call exchange traded funds (the "**ETFs**"), for the period ending February 28, 2018, as indicated in the table below.

The ex-dividend date for the Distributions is anticipated to be February 27, 2018, for all unitholders of record on February 28, 2018. The Distributions for units of each ETF will be paid in cash or, if the unitholder has enrolled in the respective ETF's dividend reinvestment plan ("**DRIP**"), reinvested in additional units of the applicable ETF, on or about March 12, 2018.

The amount of monthly cash distributions are expected to fluctuate from month to month, and there can be no assurance that an ETF will make any distributions in any particular month or months. Monthly distributions will be paid in cash, unless the investor has chosen to participate in the ETF's reinvestment plan.
